

UPDATE: new Rehabilitative Program now effective August 1, 2019

Anthem Blue Cross and Blue Shield (Anthem) previously communicated in the [April 2019 edition](#) of Anthem Provider News that AIM Specialty Health® (AIM), a separate company, would begin to perform prior authorization review of rehabilitative (restoring function) and habilitative (enhancing function) services for Anthem fully insured members beginning July 1, 2019. Due to recent group membership, provider status, and system issues experienced by Anthem and AIM, **the program will now be implemented on August 1, 2019.** *Effective through July 31, 2019 for requests in progress and for new requests, coverage for Physical Therapy (PT), Occupational Therapy (OT) and Speech Therapy (ST) visits will not require a prior authorization.*

AIM will manage Physical Therapy (PT), Occupational Therapy (OT) and Speech Therapy (ST) medical necessity reviews and will require prior authorization for all outpatient facility and office-based rehabilitative and habilitative services following the initial evaluation. AIM will use the following Anthem Clinical UM Guidelines:

AIM will now begin accepting prior authorization requests on July 17, 2019 for dates of service on and after August 1, 2019. Ordering and servicing providers may submit prior authorization requests to AIM in one of several ways:

to request authorization.
